Should have a keen concern for ARS welfare, and exhibit a broad interest in the work and affairs of the national organization.

Should be aware that Directors serve as volunteers, and should have time to devote to ARS affairs.

Should be prepared to accept financial responsibility for attending at least one national convention per year.

Should be able to attend regularly scheduled district meetings and events at his/her expense.
